The *rating system of Officials has been changed to Levels as per the General Regulations and Education system, across all disciplines.

AUS - Australia does not support the change to an L rating system and believe it would be both divisive and disruptive and offers no benefits.

The use of STARS * is universally recognised worldwide (regardless of language) as a descriptor of quality, importance or expertise. Thus, it has become a highly meaningful and an important marketing tool and indicator of status influencing all stakeholders, riders, judges, trainers and organisers plus spectators. Using the STAR rating is also consistent with the way competitions are described, 1* thru 5*. --> Retain current 5* judging rating system.

NZL -

NZL does not support the proposed draft

FEI GENERAL ASSEMBLY

This proposed article change seeks to change the descriptor from the current Star nomenclature (2* to 5*) to Level 1 to Level 4.

This change to an L rating system appears to offer no benefits to the sport and may cause confusion in a well accepted system for dressage.

The use of STARS * is universally recognized worldwide (regardless of language) as a descriptor of quality. Thus it has become a highly meaningful and an important marketing tool and indicator of status influencing all stakeholders, riders, judges, trainers, organizers and spectators. The L descriptor carries no connotation nor context. 5* is recognised universally, L4 suggests nothing how many L's are there? Using the STAR rating is also consistent with the way competitions are described, 1* thru 5*. --> No change

ARG - WE REJECT THE PROPOSAL

This article seeks to change the descriptor from the current Star nomenclature (2* to 5*) to L1 to L4.

This change to an L rating system would be both divisive and disruptive and offers no benefits. Although this may seem a trivial issue it has important implications. The use of STARS * is universally recognized worldwide (regardless of language) as a descriptor of quality, importance or expertise. Thus it has become a highly meaningful and an important marketing tool and indicator of status influencing all stakeholders, riders, judges, trainers and organizers plus spectators. The L descriptor carries no connotation nor context. 5* connotes ne plus ultra universally, L4 suggests nothing how many L's are there? Using the STAR

rating is also consistent with the way competitions are described, 1* thru 5* --> We propose maintenance of the traditional star rating.

ESP - We are strongly opposed to the change from categorization of officials by stars to categorization by levels. The same comment applies to all other articles where this change has been implemented (ie Art. 441 & 446)

RUS - We propose to keep the Star rating system for Dressage judges. We greatly prefer the Star nomenclature (2* to 5*) to the levels. We believe that changing to a L rating system offers no benefits. The use of Stars (*) is worldwide recognized as a description of quality and expertise. It is a meaningful and important marketing tool and indicator of status influencing all stakeholders: riders, judges, trainers, organizers, plus spectators and sponsors. (For example, the presence of 5* judges elevates the overall standing of a Competition). The L descriptor carries no connotation and suggests nothing.

Judging plays an integral part in dressage Competition and differs substantially from judging of other equestrian disciplines. Thus the goal of harmonization among disciplines is misleading. There is no contradiction with the General Regulations which recognize the possibility that there will be variations amongst disciplines and leaves the determination of levels to the disciplines via the Sport Rules.

Proposed wording:

Keeping the Stars nomenclature <u>throughout</u> the Dressage Rules and other documents

Art. 441

Judges are divided into four (4) categories: Level1 (L1), Level 2 (L2), level 3 (L3) and Level 4 (L4) 2*, 3*, 4*, 5*. The qualifications and minimum requirements for L1, L2, L3 and L4 2*, 3*, 4* and 5* Judges shall be published separately by FEI and shall be governed by the FEI Dressage Judges Education System.

POR - We fully support the IDRC and IDTC proposal to reinstate the 5* classification for the highest level of Dressage Judge. The change to an "L" rating system would be both divisive and disruptive and offers no benefits. The use of STARS * is universally recognized worldwide (regardless of language) as a descriptor of quality, importance or

expertise. Thus it has become a highly meaningful and an important marketing tool and indicator of status influencing all stakeholders, riders, judges, trainers and organizers plus spectators. The L descriptor carries no connotation nor context. Using the STAR rating is also consistent with the way competitions are described, 1* thru 5* Proposed wording:

"At all international Dressage Competitions, the Ground Jury must consist of a minimum of three (3) and a maximum of seven (7) members as described in Annex 7. Members of the Ground Jury shall be International Judges from the FEI list. Judges are defined in four (4) categories: 2* (new), 3* (formerly International Candidate), 4* (formerly International) and 5* (formerly Official international) Judges."

NOR - We see the rationale in harmonising the categories of officials across the disciplines, into 4 levels, as it was decided at the GA last year. However, we do not agree to rename the categories of judges in dressage from a star rating 2*-5* to L1-L4. Our reasoning for this decision is in accordance with the arguments received from the stakeholder groups in dressage, IDTC, IDRC,IDOC and AIDEO.

JPN - The use of STARS * is universally recognized worldwide (regardless of language) as a descriptor of quality, importance or expertise. Therefore, we think that we will continue to use The STARS *.

Proposed wording:

- Judges are divided into four (4) categories: Level1 (L1) 2* (new), Level 2 (L2) 3* (formerly International Candidate), level 3 (L3) 4* (formerly International) and Level 4 (L4) 5* (formerly Official international). The qualifications and minimum requirements for L1, L2, L3 and L4 Judges shall be published separately by FEI and shall be governed by the FEI Dressage Judges Education System.
- **HON** We are asking you to REJECT the proposal to change the rating descriptor for the FEI Dressage Judges as listed in Chapter VII Officials Article 440.
- **EST** The Estonian NF is supporting the initiative of IDOC, IDRC, IDTC and AIDEO to reject the proposal to change the descriptor from the current Star nomenclature (2* to 5*) to L1 to

L4.

We are of the opinion that the current STAR system is well suited for dressage, as it expresses better the essence of more complex dressage judging as opposed to the more technical LEVELS in show jumping and stewarding. Also, it works well for the dressage community and as an unnecessary change, it would be a waste of resources that could be located elsewere, e.g, officials education, etc.

- CAN Canada supports the letter from IDOC submitted August 2022
- **COL** We <u>reject the proposal in the Rule Revision</u> <u>Proposal Draft</u> which would change the name designation for FEI Dressage Judges. We propose judges continue to be designated using a Star rating system and ask FEI to remove this change from the DRAFT RULE REVISION PROPOSALS. --> No changes to actual wording of Judges Categories.
- MEX keeping star levels
- **BEL** This change to an L rating system would be both divisive and disruptive and offers no benefits. Although this may seem a trivial issue it has important implications. The use of STARTS* is universally recognized worldwide (regardless of language) as a descriptor of quality, importance or expertise.

Proposed wording:

Reinstate the 5* classification for the highest level of dressage judge.

IDTC /IDRC / EEF/ GRE - We object to elimination of the Star * descriptors for the Judges. This descriptor has meaning and value to all stakeholders and is easily understood by spectators worldwide. It can be used as a marketing tool both within and outside of the dressage community.

There is no compensating benefit for the shift to Levels. If harmonization is important then it makes sense to maintain the Star designation as that is how the competitions are described. Issues regarding harmonization should be consumer-facing and not for internal purposes. The Dressage Committee as well as the Stakeholder Clubs are united in their opposition to this change

Proposed wording:

Article 440 Judges are divided into four categories: 2 Star, 3 Star, 4 Star and 5 Star

Wording throughout Article 441 Ground Jury should be appropriately adjusted to reflect the maintenance of the Star designator

NED - We see no benefit and necessity in this name change from * to Levels. The star system is used throughout the complete FEI infrastructure and immediately gives everyone a sense of importance, either for a judge or competition. This is due to the worldwide recognition of a star system as a prove of certain quality. We do not agree with the rationale from the FEI and reject this proposal

USA - We have received a strong lobby from Judges requesting the star system is retained rather than Levels. However, we understand the wish to have universality across the disciplines.

AUT - The AUT NF REJECTS the proposal to change the rating descriptor for the FEI Dressage Judges as listed in Chapter VII Officials Article 440.

We strongly support the opinion of all stakeholder clubs IDOC, IDTC, IDRC, AIDEO in this case and ask the FEI to remove this from the DRAFT RULE REVISION PROPOSALS:

ARTICLE 440 JUDGES CATEGORIES

1. Judges are divided into four (4) categories: Level1 (L1), Level 2 (L2), level 3 (L3) and Level 4 (L4). The qualifications and minimum requirements for L1, L2, L3 and L4 Judges shall be published separately by FEI and shall be governed by the FEI Dressage Judges Education System.

This article seeks to change the descriptor from the current Star nomenclature (2* to 5*) to L1 to L4.

This change to an L rating system would be both divisive and disruptive and offers no benefits.

Although this may seem a trivial issue it has important implications. The use of STARS * is universally recognized worldwide (regardless of language) as a descriptor of quality, importance or expertise. Thus it has become a highly meaningful and an important marketing tool and indicator of status influencing all stakeholders, riders, judges, trainers and organizers plus spectators. The L descriptor carries no connotation nor context. 5* connotes nec plus ultra universally, L4 suggests nothing how many L's are there? Using the STAR rating is also consistent with the way competitions are described, 1* thru 5*. The FEI's rationale for this change is to be consistent with the General Regulation Chapter VII Article 145- Judge point 3. Unless the Sport Rules provide otherwise, there shall be four (4) levels of Judges. The necessary qualifications for each Level are set forth in the Education System for each Discipline.

This rationale is misleading. The above regulation stipulates NO specific descriptor for the 4 levels and also provides flexibility for the disciplines if they so please. Therefore, there is no requirement to change any descriptor.

It is also important to highlight that this change does NOT have the endorsement from the FEI Dressage Committee.

Regarding this Article as AUT NF we also like to support the letter of Linda Keenan and go with her opinion (End of the doc): Article 145 Judge

3. Unless the Sport Rules provide otherwise, there shall be four (4) Levels of Judges. The necessary qualifications for each Level are set forth in the Education System for each Discipline'

Discussion

- 1. ARTICLE REINFORCES STATUS QUO
- -There is no mention of how the levels may (must) be identified
- -The principle of Sport Rule precedence is clearly stated
- -Dressage currently has 4 levels of officials

it can be reasonably inferred that this wording simply reinforces the status quo and the NF's would not have believed that they were imposing anything new on the dressage discipline.

2. NAME CHANGE WAS NOT SOUGHT IN SPORT RULES

because no change was made in the Sport Rules where the 4 levels of judges continues to be referred to using the * designation; and the principle of Sport Rule precedence is affirmed in the General Regulations several times it is unreasonable to assume that the NF's would anticipate any required change in naming convention for any of the disciplines nor that they were creating a mandate for a name change

3. SPORT RULE PRECEDENCE

Even if, Article **145.3** did include a direction as to the designation of judges the fact of **no change in the Sport Rules** would mean that the designation as written in the Sport Rules should dominate. No expectation or any name change on behalf of the NF's would have been created.

All that can be concluded from the approval of Article 145 is that the NF's supported having 4 levels of judges and other officials. The only implication is that some disciplines/officials would have to add an additional level.

Harmonization is beneficial if it improves clarity, has a positive outcome and provides sufficient flexibility for future growth and development. There is no point in forcing square pegs in round holes just to be able to produce a tidy organization chart. Structure must follow function.

GBR - We do not believe that there is the justification or a sound rationale to change the judge category descriptors from the current star status (2* to 5*) to L1 to L4. While we understand the wish to align this to the education system, this could still sit alongside and support the existing star status without any changes required.

Changing to a L rating system would be divisive, disruptive and offers no real benefits in terms of wider public perception or recognition. The use of stars is universally recognised internationally (regardless of language) to indicate quality, importance, or expertise. It is a meaningful tool to convey the level of experience and status of judges to all stakeholders, including riders, trainers, organisers, and spectators alike.

The L descriptor would undermine this and create unnecessary confusion, especially without any real context for the public to understand. Whereas 5* status universally

denotes the ultimate level that can be achieved, L4 is meaningless – it could be viewed as a demotion for highly respected judges and carry less prestige or importance.

Using the star rating is also consistent with the way competitions are described, from 1^* through to 5^* , so this measure is already universally recognised and understood in the sport. There is therefore no reason to change this valuable and important reference to judge status and we believe it would be counter-productive.

Proposed wording:

We would recommend that L1 to L4 is utilised in the context of the training and education system only, and that the judge star status remains in place, as at present.

The FEI Board had agreed in June that Levels shall be used but that the L4/5* reference could be used in all working documents

The DC proposed to change the formats for CDIs to show more progression through the levels. This was both to encourage Athletes to start at an appropriate level to develop the lower levels of events, as well as to make each level Events clear is what it offers.

Small Tour, Medium Tour and Big Tour are now each separate CDI *rating level and no longer called ST, MT and BT.

Types of Events for Senior Athletes:

In conformity with the FEI GRs, the International Dressage Events are divided into CDI1* to CDI5*, CDI-Ws, CDIO1* to CDIO5*, CDIO-NC, CDIYH, CDIAm, FEI Championships, Regional and Olympic Games which must be held according to the Rules given in the following articles, unless otherwise stated in the preemptive Rules for any of these Events, such as the Olympic Games or Paralympic Games.

Explanation for Proposed Change

In CDIs and CDIOs, the last individual Competition will be open to the eighteen (18) best from the second Competition across all categories. In the current rules, the last Competition is open to either the best 15 or best 18, and the DC is proposing to harmonize this across all.

The Draw for the last Individual Competition will be done in four groups instead of three.

Proposed Wording on 6 July 2022

Example Art. 407.2.5

<u>Third Competition:</u> This Competition shall be open to the six (6) (minimum) to <u>fifteen eitheeneighteen (1518)</u> (maximum including ties for <u>15th 18th</u> place) best Athlete/horse combinations who qualified in <u>the second Competition</u>. It is at the discretion of the OC to make the <u>third test mandatory</u> or not. This must be stated in the Schedule. <u>The minimum qualification score for must be applied</u>.

Example Art. 417.7.3

For the Children Individual Competition and all Youth Freestyle Competitions there will be a draw withinin four (4) groups, in reverse order from the rankings of the previous Competition. First drawn is a group of three (3), with athletes placed 18th to 16th. The Athletes in the group ranked 18th to 16th will start first, followed by the group ranked 15th to 11th, and so on.

USA - We recommend 62% or 63% (instead of 65%) to participate in a CDI4* and qualify for the final test in a CDI4*. If the data proves this is too low after several years, then it can be raised; however, since this would be a new requirement, a lower percentage is suggested. Consideration should be given to the impact on athlete/horse combinations seeking a start in a CDI4* and the number of potential CDI4*s going forward to the calendar for the 2023 competition year prior to these rules being approved.

3.1 Degree of Difficulty: The FEI Freestyle <u>Degree of Difficulty (DOD)</u> must be used at Championships, Games, Finals, <u>CDI5*</u> and CDI-W WEL in Grand Prix Level. The system may be used at CDIs/CDIOs, at Grand Prix level Competitions at the discretion of the OC. Whenever used, it must be announced in the FEI approved Schedule. AUT - This is not possible for all OCs and therefore we should add: whenever possible.

USA - We support the aim that the Judges' huts should provide for suitable cover/shelter; however, there are situations where it would be impossible or at least, very expensive, to provide heating or cooling in Judges huts at all levels. It is suggested that wording is added to allow a practical and realistic approach. Proposed wording:

The OC must ensure that the Judges' huts provide shelter. The Judges' huts should be are suitably heated or cooled depending on weather conditions to the extent feasible.

The DC proposed changes in the process on false tails, ear hood checks etc. and clarifications to other elements.

The Annex 11 is removed, as it is to be replaced by and will be included in the "FEI Dressage and Para Dressage Guidelines for Use of Tack, Equipment and Dress", to be published on the FEI website.

Proposed Wording on 6 July 2022

The following are compulsory:

- 1. **Dressage saddle**, which must be close to the Horse must be well-fitting and have long, near-vertical flaps, English-style or safety stirrups and a girth.
- 1.1 **Stirrups** must have closed branches, and no attachments. <u>Safety stirrups may have an opening on the outside branch</u>. The foot must not be fully or partially enclosed and must in no way be attached to the stirrups (for example with magnets).
- **Saddle pads** should be white <u>or off-white</u>. Plain colour saddle pads may be used. Contrast colouring and piping is allowed. Striped or multi coloured pads are not permitted.
- 1.3 No saddle covers are allowed.
- 1.4 Pommel straps are allowed.
- 2.1.6 Any piece of tack that impairs the ears to move freely is forbidden.
- 2.1.7 A **double bridle** <u>must have a</u> cavesson noseband <u>and</u> bridoon and curb with curb chain. A combined noseband may be used without the lower "flash" strap. Neither a cavesson noseband nor a curb chain may ever be as tightly fixed so as to harm the Horse.
- 2.2.1 A snaffle bridle or double bridle is allowed in CDI1* and 2*, <u>CDIO1*</u>, CDIO2*, CDIJ, CDIOJ, CDIY, CDIOY, and CDIYH for seven (7) year old Horses, and Junior and Young Rider Championships.
- 3. **Bits**. Snaffle, Bridoon and curb bits must have a smooth surface. Twisted and wire bits are prohibited. Bits must be made of metal, rigid durable plastic flexible rubber or synthetic material. Bits and may be covered with rubber/latex. Bits must not place mechanical restraint upon the tongue. The diameter of the mouthpiece of the bridoon/snaffle and/or curb must be such so as not to hurt the Horse. Minimum diameter of mouthpiece to be twelve millimetres (12 mm) for curb bit, and ten millimetres (10 mm) for bridoon bit. Snaffles must have a

minimum diameter of twelve millimetres (12 mm) for Horses and ten millimetres (10mm) for Ponies. The diameter of the mouthpiece is measured adjacent to the rings or the cheeks of the mouthpiece.

- 4.1 Upon arrival on the showground, only the Athlete when riding, walking in hand, leading or lunging a Horse (lunge whip allowed), is allowed to <u>use</u> a whip (maximum one meter and twenty -1.20 m-/ponies maximum one --1 m-) anywhere on the showground in connection with the training of the Horse. The groom may also walk, lead and lunge a Horse as above. Other parties are allowed to carry a whip, provided it is not in connection with the training of the Horse. For safety reasons, whips at prize-giving ceremonies are allowed
- False tails/tail extensions are permitted. False tails may not contain any metal parts, (except for hooks and eyelets), or extra added weight. Random checks will be conducted and contravening this rule will entail a Yellow Warning Card and Elimination.
- 6.2 Ear hoods are permitted for all Events and may also provide noise reduction. However, ear hoods must not cover the horse's eyes. The ear hoods should be discreet in colour and design. Ear hoods may not be attached to the noseband.
- 6.2.1 Earplugs on Horses <u>are forbidden but are allowed at Horse Inspections and prize-giving ceremonies only for safety reasons. Random checks will be conducted and contravening this rule will entail a Yellow Warning Card and Elimination</u>
- Any <u>artificial</u> decoration of the Horse is not allowed. It is not allowed to paint any part of the horse's body. <u>Using coloured wound spray and ointment if necessary is permitted, but it cannot be used nor is it allowed</u> to obscure an existing wound or injury. <u>Contravening this rule will entail a Yellow Warning Card and Elimination</u>.
- 6.4 it is strictly forbidden to use any type of white substance (like "marshmallow fluff", shaving cream etc.) around the horse's mouth to imitate foaming; contravening this rule will entail a Yellow Warning Card and Elimination.
- 7. Fly masks: fly masks are forbidden in the training and Competition arena but may be allowed in warm-up and training arenas at the discretion of the Chief Steward and President of the Ground Jury.
- 8.1 It shall be the Athlete's/groom's responsibility to remove ear hoods when required.
 - The Steward must use disposable surgical/protective gloves when checking the bridle ($\frac{\text{one }(1)}{\text{a new}}$ pair of gloves $\frac{\text{must be used}}{\text{per Horse}}$).
- 10. **Identification number**. Each Horse keeps the same identification number provided by the Athlete throughout the Event. It is compulsory that this number is worn by the Horse while actively competing and at any time while working in the exercise and schooling areas or being hand walked (from the time of their arrival until the end of the Event) so that they can be identified by all Officials including the Stewards. Failure to display this number incurs firstly a warning and, in the case of a repeated offence, a fine imposed on the Athlete by the Ground Jury. The identification numbers shall be discreet on white

Dressage saddle:

We are concerned that this may be too subjective and beyond the scope of the officials' duties to determine if a saddle is well fitted.

AUT - From the Stewards Department Point of view:

Check of false tails will usually be conducted at the horse check immediately after the horse leaves the arena, the same is true for 6.3 earplugs: as bonnets have to be removed and, as far as the safety from horse, rider and steward allows, the ears are checked.

A random check during warm-up is hardly possible without interrupting the riders concentration, and in art 434.8 it is stated, that a (visual) check is not compulsory before the athlete enters the field of play. A voluntary review of the tack is always possible and is often being asked from riders.

Anyhow I agree that contravening the rules about false tail/extensions or extra added weight, earplugs, artificial decoration and fly masks should be penalized with Yellow Warning Card and Elimination.

GBR - We would suggest that if the groom is busy leading the horses with the rider on board, occasionally another member of the support team (such as the Chef d'Equipe) may carry the whip or pick it up on behalf of the rider or groom.

The article, as it stands now, is also contradicted by Article 439.1 which allows the trainer to lunge the horse (who may carry a lunge whip). Proposed wording:

Upon arrival on the showground, only the Athlete when riding, when walking in hand, leading or lunging a Horse (lunge whip allowed), is allowed to use a whip anywhere on the showground in connection with the training of the Horse. The groom may also walk, lead and lunge a Horse as above, and may also carry the whip on behalf of the rider. There are times in a panel of 5, when one judge may see something (example: tongue) and the others do not due to where they are seated.

NOR NF: The DC doesn't support the idea of using the 5% rule at all shows all over the world for the following reasons:

- In some countries the OC doesn't use special counting computer programs which can without mistakes select such large deviations and quickly correct them while the show is continuing to run. Some still count manually and this can cause mistakes and delays.
- Many shows are judged with 3 judges only and this rule cannot be applied. Quite often within one show some classes are judged with 3 judges some with 5. We want to avoid situations when this rule is applied in one class and then not applied in the other class within the same show, because it can cause confusion.
- At smaller shows we cannot guarantee that all invited judges will be on the same level of experience. We might have a case, when, for example, only one very experienced 5* judge is invited, and the other judges are less experienced and want to learn from him/her. The marks of this judge might at times be different. We want to avoid the situation when the results of this most experienced judge are changed. We believe that the less experienced judges should learn from him/her, and the riders would like to get the result of this judge as well.

The DC does support applying the 5% rule to Youth Championships for the following reasons:

- The CHs are always judged by 5 judges,
- All judges are very experienced, carefully selected by the JSP and appointed by DC;
- There is always an excellent computer system used, which can deal with large deviations without any mistakes or delays.

This was proposed by us last year and deferred to the 2022 full revision:

The goal is to find an "Amateur" definition that is valid for international Competitions in all three Olympic disciplines of Dressage, Jumping and Eventing. Amateurs should be offered a range of events/Competitions that are exclusively open to this target group, where they can compete under fair and equal conditions, at their level and not against professionals.

The proposal is based on ANNEX XIII RULES FOR AMATEUR OWNER CATEGORY of the FEI Jumping Rules, 26th edition, updates effective 1 January 2021, however it should be part of all three Olympic discipline rules and/or the General Regulations. It is not deemed necessary to define the Amateur status for any of the other FEI disciplines.

The term "Amateur" instead of "Amateur Owner" should be used.

There is no concrete definition what "immediate family members" and "sponsored Horses" are. Therefore it would be best not to use these terms.

Proposal

ARTICLE 1 REQUIREMENTS

- 1. To be considered an "Amateur Owner":
- 1.1. The Athlete must be the owner of the Horse(s) with which he/she competes. Ownership may be extended to the immediate family members.
- 1.2.1. The Athlete must possess a valid licence granted by his/her NF and be registered with the FEI. Horses must be registered with the FEI and, if competing in a country outside the Horse's country of residence, have a valid FEI passport or a national passport with an FEI recognition card. Horses competing in Amateur Events in their country of residence do not need an FEI passport or FEI recognition card but must be registered and identifiable (see GRs 137.2).
- 1.2.1.1. An "Amateur-Owner's" license will only be granted by NFs to an Athlete who has formally signed a statement that he/she does not earn money for riding other people's Horses, giving riding lessons, riding sponsored Horses, or for publicity or commercial purposes, etc. The buying and selling of Horses, as well as receiving prize money in cash, are not forbidden providing they do not constitute the Athlete's only main source of income.
- 1.3.2. The "Amateur—Owner" status limits participation in other Competitions and Championships. Athletes having obtained or renewed the "Amateur—Owner" license, will not be allowed to continue participating as an Amateur during the current calendar year if in Jumping:

They have taken part in international or national Competitions in which the height of obstacles in the initial round is 1.50 m or greater.

This means for example that a Young Rider who has obtained his/her Amateur license and who reaches the Individual Final Competition at the Continental Championships for Young Riders may no longer participate as an Amateur for the remainder of that year. An Athlete may apply to his/her NF to reinstate his/her Amateur Owner license after a waiting period according to the regulations of the NF but under no circumstances during the same calendar year.

- In Dressage:

The Athlete/Horse combination has obtained 3 results with a score of at least 73 % in international non-Amateur Grand Prix Competitions.

- in Eventing:

Currently not applicable, to be determined; could be related to the rider's category or results of the rider/horse combination.

1.4.3. Age of competitors:

- in Jumping:

Athletes may participate in all CSI Amateur Competitions from the year in which they reach the age of 14 years.

Athletes from the year in which they reach their 12th birthday until the end of the year in which they reach their 13th birthday may participate in CSI Amateur Competitions providing the height of obstacles does not exceed 1.30 m (see JRs Art. 255.2).

In 2021, the GER NF proposed an update to the Amateur definition to include;

- In Dressage: the Athlete/Horse combination has obtained 3 results with a score of at least 73 % in international non-Amateur Grand Prix Competitions.
- Define athlete age
- Dressage: International Events for "Amateurs" may be organized as CDIAm Events at any level.

FEI Comment: The new definition of Amateurs will be included in the General Regulations (see General Regulations memo) with the following minor amendment for the Age of Competitors for Dressage in line with the relevant Dressage Rules. For Dressage the review of the Amateur criteria will be carried out in connection with next year's full rule revision.

The Dressage Organizers believe this proposal is too complicated and not easily understood. We believe that any change must be an improvement to the current requirements and must be easily understood in order to be supported by riders and organizers.

RULES FOR DRESSAGE AMATEUR CLASSES CDIAM

Article 1 GENERAL PRINCIPLES

The objective of the following set of regulations is to standardize types of Competitions for Amateur riders throughout the world, taking into account specific conditions applying exclusively to this level of riders. The FEI Rules for dressage events apply to all international dressage events for Amateur riders except where stated differently below. When judging Amateur classes judges have to use exactly the same principles and judging criteria as at all other CDIs.

DEFINITION OF AN AMATEUR RIDER

An Amateur rider is an athlete, who does not earn most of his/hers income from within the equestrian sport, such as giving riding lessons, training horses for third parties, professional horse dealing/breeding, doesn't hold any valid riding instructor/trainer license and is not getting an education as a professional rider/trainer. The buying and selling of horses, as well as receiving prize money in cash, is not forbidden providing they do not constitute the athlete's main source of income.

ARTICLE 2 CONDITIONS OF PARTICIPATION

1. Registration

Athletes must be registered with the FEI. Horses must be registered with the FEI and, if competing in a country outside the Horse's country of residence, have a valid FEI passport or a national passport with the FEI recognition card. Horses competing in Amateur Events in their country of residence do not need a FEI passport or FEI recognition card but must be registered and identifiable.

2. Amateur's license



13 November 2022, Cape Town (RSA)

The Athlete must possess a valid Amateur's license granted by their NF. The Amateur's license must be renewed by the NF every year. The NFs are responsible for verifying all the data provided by the Athlete.

An Amateur's license can only be granted by NFs to the Athlete who has signed a statement that the Athlete does not earn most of his/hers income from within the sport such as giving riding lessons, training horses for third parties, professional horse dealing/breeding, doesn't hold any valid riding instructor/trainer license and is not getting an education as a professional rider/trainer, etc. The buying and selling of Horses, as well as receiving prize money in cash, are not forbidden providing they do not constitute the Athlete's main source of income.

An Amateur's license cannot be granted or can be suspended in the following cases:

- the Athlete participated in international non-Amateur Grand Prix Competitions in Grand Prix or Grand Prix Special with a result of 68% and over more than twice in the last 5 years. The rider is not eligible to get an Amateur's license for 5 years from the date when the second result was earned.
- the rider has participated in the FEI Senior Continental Championships, World Championships, World Cup Finals, Olympic Games in the discipline of Dressage within the last 5 years.

3. Age of Athletes

An athlete may compete as an amateur rider from the beginning of the calendar year in which he reaches the age of twenty six (26).

4. Age of horses

ARTICLE 3 DRESSAGE TESTS

1. CDIAm: Senior tests up to and including FEI GP and GP Freestyle, excluding GP Special.

It is at the discretion of the OC to decide which levels of tests to schedule and to make the Freestyle mandatory or not. This must be stated in the Schedule. Maximum three tests allowed, opting will be possible if three tests are scheduled.

At any event, the same athlete/horse combination can, however, only take part in Competitions of the same level, as defined below:

<u>Small Tour:</u> Prix St. Georges – Intermediate I – Intermediate I Free Style

<u>Medium Tour:</u> Intermediate II - Intermediate A - Intermediate B - Intermediate A/B Freestyle

Big Tour: Intermediate II - Grand Prix - Grand Prix Free Style.

2. Number of horses

At all amateur events, the number of horses that an athlete may ride in each Competition is limited to 2 (two), except for Freestyle tests in which each athlete may ride only one (1) horse.

The Athlete doesn't receive any WDRL points and cannot fulfill any qualification requirements after participating in the Amateur Big Tour Competitions.

Then, some riders who comply with all other conditions to be classified as amateur riders may integrate the national team for that competition.

Therefore, to avoid any questions about the rider's qualification as an amateur rider, We would like to be more specific about the FEI Senior Continental Championship or to erase the second condition, keeping only the first one.

GBR - We appreciate that this information has now been included within the bulk of the rules; however, Annex 3 was a comprehensive single reference point. Would it be possible to reinstate this, in the same way as the Sanctions have been included in the bulk but summarised as a table in the Annex? This would be much appreciated.

As a more general point, annexes with tables are very useful as reference points, so we would question the rationale for removing some and adding others. This is a good opportunity to tidy up the rules, reduce duplications, clarify context, and make them easier to understand. Some of this seems to have been addressed, but in other cases there are still some rules that are either open to misinterpretation or appear contradictory.

AUT - We are having trouble with the whole new Annex. Not sure if that helps the amateurs in any way. What if the NF does not have Amateur's licenses? Who controls the requirements to be an Amateur? Do we really want to see Amateur GPFS?

This is achieved by a panel of official judges awarding scores from 0-10 for movements as described in the current FEI Rules for Dressage and other official documents such as the FEI Judges Handbook and FEI Key Observations & Scores. The regularity of the horses gaits, the function of its biomechanics and body, and its mental willingness are some of the key criteria which determine the assignment of scores.

In the rules it says, Grand Prix, including Grand Prix Special and/or Grand Prix Freestyle, in the CDI2* it says Grand Prix excluding Grand Prix Special and/or Grand Prix Freestyle. For me and also for the OC of Hagen this means that in a CDI3* it is possible to schedule Grand Prix Special and/or Grand Prix Freestyle, but not in a CDI2*.

In order to avoid any further discussion, the "stand alone" Grand Prix should be taken out from the schedule possibilities:

1. Protective Headgear and Top Hat/Bowler

Explanation for Proposed Change

Explanation

We repeat this request although it was not agreed to by the FEI Medical Committee and the FEI Board ("vote of 2019 GA to be respected"), because we are convinced that it is a just request.

We propose to amend the existing obligation to wear a helmet.

The traditional dress code with an elegant hat is a world-renowned recognition feature of Dressage sport. We do not want to give the impression that Dressage sport has become dangerous. We acknowledge the aspect of safety, however we are not aware of any head injuries that have ever occurred to top Athletes during a high-level Dressage Competition.

Therefore, Athletes of the age category U25 and older should have the freedom to decide for themselves whether they want to wear a top hat or a helmet in the Competition. This freedom of choice should only apply to CDI4*, CDI5*, Championships and Games on Grand Prix level. For awards ceremonies and at all other times when mounted, the use of protective headgear shall remain mandatory.

1.1 As a general rule, a properly fastened Protective Headgear* has to be worn by all Athletes (as well as any other person) at all times when mounted and by Children, Pony riders, Juniors, Young riders and U25 for the Horse inspection. It is recommended to be worn by any other person presenting the Horse in a Horse Inspection.

As an exemption from the above rule, Athletes of the age category U25 and older can decide to wear a top hat or a helmet while riding in a Grand Prix level Competition at a CDI4*, CDI5*, Championship or at Games.

1.2 Any Athlete (as well as any other person) violating this provision must immediately be prohibited from further riding until the Protective Headgear is properly in place. If an Athlete chooses to remove his Headgear at any time, whether permitted or not by these rules, such removal shall always be entirely at his own risk.

1.3 A Protective Headgear formed as a top hat may be used.

2. Correction of inconsistencies, manifest errors, contradictions, etc. :

The FEI Jumping Rulebook allows for "flat disk" spurs according to Article 19:

"...Spurs with flat disks are allowed. The contact surface with the horse and all edges must be smooth and rounded" (pg. 105).

We propose that this be added to the FEI Dressage Rules to align with what is already permitted in the FEI Jumping Rules. This is an inconsistency that appears to be the result of an unintended omission. As well, because the rules governing spurs are based on the safety and welfare of the horse, by omitting flat disk spurs in the Dressage Rulebook we may be contradicting the very purpose of regulating what spurs are/are not permitted at FEI Events:

Article 427. 4. Spurs are compulsory except for CDIP and CDICh Events and must be made of metal. The shank must be either curved or straight pointing directly back from the centre of the spur when on the Athlete's boot. The arms of the spur must be smooth and blunt. If rowels are used, they must be blunt/smooth (no sharp edges) and free to rotate. Metal

427.4 – Through developing technology, allow other forms of material to be used as an alternative to metal. E.G. Polyamide a rubber-based material that is designed for more comfort for horse and rider. Must have the ability to flex in all directions to show that the spur itself does not snap. We fully support that plastic-based material that can snap are not permitted, however, there are some new items within the marketplace that would be acceptable to use and comply with any welfare concerns. Include must be worn in their manufactured state as this then allows any spur with degradation shown, falls under an elimination.

Explanation for Proposed Change

Explanation

Bits. Snaffle, Bridoon and curb bits must have a smooth surface. Twisted and wire bits are prohibited. Bits must be made of metal, rigid plastic, or durable synthetic material and may be covered with rubber/latex. Bits must not place mechanical restraint upon the tongue. The diameter of the mouthpiece of the bridoon/snaffle and/or curb must be such so as not to hurt the Horse. Minimum diameter of mouthpiece to be twelve millimetres (12 mm) for curb bit, and ten millimetres (10 mm) for bridoon bit. Snaffles must have a minimum diameter of twelve millimetres (12 mm) for horses and ten millimetres (10mm) for Ponies. The diameter of the mouthpiece is measured adjacent to the rings or the cheeks of the mouthpiece.

Proposal

- 3.1 Snaffle Bits snaffle bits are permitted when the use of a double bridle is not required.
- 3.1.1 Snaffle bits may be used with loose ring, D-Ring, Eggbutt and hanging cheeks. Single or double jointed snaffles may also be used with upper or lower cheeks, full cheeks or Fulmer cheeks. Loose rings may have a sleeve fitted around part of the ring. The upper cheek of a hanging cheek (baucher) snaffle (measured from the top of the mouthpiece to the top of the upper cheek) may not exceed five centimeters (5 cm).
- 3.1.2 Flexible rubber or synthetic mouthpieces are permitted.
- 3.1.3 A snaffle may have up to two joints. In a double-jointed snaffle the center link must be smooth with rounded edges and curved on all surfaces as in a lozenge-shaped link. It may not have the effect of a tongue plate. Dr. Bristol and French link bits are not allowed. A bushing, barrel, coupling, or ball joint is permitted as the center link in a double-jointed bridoon. If the center link is a ball joint, it may have one or two joints. Only one rolling part is permitted and when present the rolling part must be in the center of the mouthpiece. A barrel or ball joint is permitted as the centre link in a double jointed snaffle, however, the surface of the centre piece must be solid with no moveable parts other than a roller. The centre link may be tilted in a different orientation from the mouthpiece but must have rounded edges. and may not have the effect of a tongue plate.
- 3.1.4 A double jointed snaffle or snaffle with rotating mouthpiece may be shaped to allow tongue relief. The maximum height of the deviation is 30mm from the lower part of

tongue side to the highest part of the deviation. The widest part of the deviation must be where the mouthpiece contacts the tongue and must have a minimum width of 30mm. The mouthpiece of a jointed or unjointed snaffle may be shaped in a curve within the dimensions specified above.

- 3.2 Bridoon bits a bridoon bit is defined as a snaffle bit that is used together with a curb bit to form a double bridle.
- 3.2.1 Bridoons may be used with only loose ring and or eggbutt cheeks.
- 3.2.2 Bridoons must have one or two joints. In a double-jointed bridoon the center link must be smooth with rounded edges and curved on all surfaces as in a lozenge-shaped link. It may not have the effect of a tongue plate. Dr. Bristol, French link and D-ring bridoons are not allowed. A bushing, barrel, coupling, or ball joint is permitted as the center link in a double-jointed bridoon. If the center link is a ball joint, it may have one or two joints. Only one rolling part is permitted and when present the rolling part must be in the center of the mouthpiece. A barrel or ball joint is permitted as the centre link in a double jointed bridoon, however, the surface of the centre piece must be solid with no moveable parts other than a roller. The centre link may not have the effect of a tongue plate.
- 3.2.3 Bridoons where the centre link(s) of the bit can lock and have the effect of a mullen mouth snaffle are not permitted.
- 3.2.4 Flexible rubber/synthetic bridoons are not permitted.
- 3.3 Curb Bits
- 3.3.1 The length of the lever arm below the mouth piece of the curb bit is limited to ten centimetres (10 cm). The upper cheek must not be longer than the lower cheek and must not exceed five centimetres (5 cm). If the curb has a sliding mouthpiece, the lever arm of the curb bit below the mouth piece should not measure more than ten centimetres (10 cm) when the mouth piece is at the uppermost position.
- 3.3.2 Curbs may have straight or S-shaped cheeks. They may have rotating lever arms.
- 3.3.3 The mouthpiece may be straight or shaped to allow tongue relief. The maximum height of the deviation is 30mm from the lower part of tongue side to the highest part of the deviation. The widest part of the deviation must be where the mouthpiece contacts the tongue and must have a minimum width of 30mm.
- 3.3.4 Curb chain can be made of metal or leather or a combination. Cover for curb chain can be made of leather, rubber or sheep skin. Curb chain hooks can be fixed or not fixed.

Competitions are becoming more and more spectator centred with intense noise (particularly indoors) with potential for causing stressful situations for horses.

In addition, there have been several incidents where the removal of the ear hoods (to check for ear plugs, etc) during the post Competition Equipment and Health Checks have caused distress to the horse. The necessity and safety of this process as is worthy of debate.

If the FEI were to permit the use of Ear Plugs and Ear Hoods during Competition this would potentially eliminate the need to remove the Ear Hoods post Competition, thus avoiding a stressful and possibly dangerous process. We would propose that random checks be made for horses returning to the stables.

The procedure can be explaned in the steward manual! Proposed wording:

Checking of Saddlery. A visual check before leaving the last warm up arena may be conducted by the Stewards to prevent Athletes going into the field of play with any forbidden equipment. A visual check can be declined, as it is designed to help Athletes but is not compulsory. However, it remains the full responsibility of the Athlete not to enter with any forbidden piece of Saddlery. A Steward must be appointed to check the Saddlery of each Horse immediately after it leaves the arena. Any discrepancy will be reported to the Judge at C and result in immediate Elimination if confirmed. The checking of the bridle must be done with the greatest caution, as some Horses are very sensitive about their mouths (see FEI Steward's Manual). It shall be the Athlete's/groom's responsibility to remove ear hoods.

The Steward must use disposable surgical/protective gloves when checking the bridle (one -1- pair of gloves per Horse).

Explanation

It appears that bleeding from one or two nostrils is not covered in current regulations. Nose blood can occur from bleeding in upper and/or lower airways (in racing horses not unusual with even lung bleeding, Exercise Induced Pulmonary Haemorrhage, EIPH, usually after exercise).

To distinguish from a suspected minor bleeding due to a small laceration of a nostril, it should be checked by an FEI Veterinarian after the ride.

Nose blood should be a reason for elimination because of the impact on Horse welfare, but also for general perception, i.e., Social License to Operate (SLO).

Proposal

7.6 Bleeding:

7.6.1 If the Judge at C suspects fresh blood anywhere on the Horse during the test, they will stop the Horse to check for blood. If the Horse shows fresh blood, it will be eliminated. The elimination is final. If the Judge through examination clarifies that the Horse has no fresh blood, the Horse may resume and finish its test.

7.6.2.1 If the FEI Steward discovers fresh blood in the Horse's mouth, nostril or in the area of the spurs during the check at the end of the test (Article 430.9), they inform the Judge at C, who will eliminate the Horse and the Athlete.

7.6.2.2 If the FEI Steward discovers fresh blood anywhere else on the Horse's body (i.e. other than the Horse's mouth, nostril or in the area of the spurs) during the check at the end of the test, the Athlete/Horse combination is not automatically eliminated. The FEI Chief Steward shall inform the Judge at C whether the Horse is fit to continue in following Competition(s) in the Event. The Judge at C will take a decision on the Horse's fitness to continue, based on the FEI Veterinarian's advice. If the Judge at C decides the Horse is not fit to continue, the Horse will not be permitted to take part in any further Competition(s) or tests at the Event, but the result(s) obtained by the Athlete/Horse combination in any Competition(s) or tests already completed shall stand.

7.6.3 If the Horse is eliminated pursuant to the above, or if the Horse is injured during the test and starts bleeding after finishing the test, it should be examined by an FEI Veterinarian prior to the next Competition to determine if it is fit to continue in the Event the following day(s). The decision of the FEI Veterinarian is not subject to appeal.

Explanation for Proposed Change

Explanation

We repeat this request although it was not agreed to by Dressage Judging Working Group and JAG last year, because we are convinced of the need for it. As this year is the time for a full revision of the rules, time and thought should be invested to look into this proposal again.

In 2018, the FEI removed the collective marks for paces, impulsion and submission on the grounds that Judges could misuse these marks to manipulate the result. The score sheets contained explanations in brackets what exactly was meant by the terms paces, impulsion and submission. Only the mark for the "Athlete's position and seat; correctness and effect of the aids" was left with the coefficient 2.

Nowadays everything is supposed to go faster and faster, to be simplified and made as equal as possible. We think that this is not the right way to improve our sport in terms of riding and judging. For some time now, it has been apparent that some principles of riding are no longer really taken into account in the tests. In our opinion, these collective marks are missing which have served the Judges as tools to illustrate the principles of Dressage training.

With his evaluation, the Judge also gives the rider and the trainer recommendations for the further education and training. It is not enough to only judge the technical execution of the test. It is often said that the judge should also recognise and judge all the principles, but the reality is somewhat different.

Since there is a collective mark for the rider, it is the logical consequence to also give a collective mark for the horse or its training status. This would force the Judge to give an evaluation of the principles of Dressage riding at the end of each test.

Including it as «general principles» in the marks given would be an important step to ensure that the basic criteria, our principles of riding, remain paramount in judging the performance of a rider-horse combination.

In January 2021, the definition of Collective mark in the Dressage Tests has been updated in accordance with the 2021 FEI Dressage rules (Art 432.4) and now reads: «Collective mark: General Impression (harmonious presentation of the rider/horse combination; rider's position and seat, discreet and effective influence of the aids)». This is included in our proposal. However, we have replaced «harmonious» by «harmony of» presentation and use this term instead of «General Impression». We have done this to avoid the misleading interpretation that it might be enough to see a «nice» harmonious ride whereas the focus should be laid on how well the interaction between horse and rider works.

The coefficient 2 shall be deleted because the new Collective mark comprises two items that each get a mark.

- 4. Collective marks: After the Athlete has finished his performance, a collective marks is are awarded for the implementation of General Principles and for Harmony of Presentation. [This change is to come into force as of 01.01.2021 with a clear definition]

- Elasticity of the steps;
- Suppleness of the back;
- Acceptance of the bridle;
- Self-carriage.

- discreet and effective influence of the aids.

The Collective mark is awarded from zero (0) to ten (10).

5. The collective marks for General Principles and for Harmony of Presentation are not given a coefficient. , as well as Certain difficult movements, can be given a coefficient, which is fixed by the FEI.

We continue to support an evaluation of the Short Grand Prix, as do many nations. As a test it places increased physical demands on the horse due to the sequence of the individual exercises. We would respectfully ask therefore whether its use could be re-considered especially since OC's are not taking advantage of its length to offer prime time scheduling slots.

The original intention when introducing this option was as part of a wider package to add to the entertainment / spectator experience at World Cup qualifiers. If it is no longer being used for this purpose then we would recommend a return to the standard Grand Prix, in the best interests of horse welfare – and also for consistency across all legs of the competition.

If the intention is to provide a pathway as the levels of shows have defined, then the minimum qualification for a 4* should also be differentiated from a 5* competition (i.e. set at 64%). DC: see proposal in this document

In so doing opportunities for championship preparation may be impacted, arguably resulting in a reduced level of performance at the very time dressage has its greatest exposure to public and media (i.e., at Championships).

For several years there has been discussion that the Nations Cup series will be reviewed, but this has not yet happened. We believe that this is a missed opportunity, as a revitalised NC could have a range of benefits. The NC series should showcase and promote our sport and offer wider opportunities for athletes and combinations to get international experience, as the team events do in jumping. We respectfully suggest this should become a priority.

This article refers to CDIO2* taking priority over, for instance a CDI5*

- Does the same also apply for a CDIO1* which is not mentioned?
- Would it make more sense to use different titles for CDIO (non-NC) to differentiate between them and avoid confusion? (may require GR amendment)

CDI2*/CDIO2* must go up to GP. This is the bridge for developing countries to GP level. Organizers of these countries will have to invest much more money to run a CDI3* instead of a CDI2*. USA - We recommend 62% or 63% (instead of 65%) to participate in a CDI4* and qualify for the final test in a CDI4*. If the data proves this is too low after several years, then it can be raised; however, since this would be a new requirement, a lower percentage is suggested. We appreciate the work of the FEI and the board, the committees and others, but the recent Email broadcasts surprised us a little, as although the individual national federations were asked for their opinions, they were more or less not taken into consideration.

It may have been misunderstood by us, but we get more and more the feeling, that this is not taken into account by the FEI committees, if we only get the statement "We decided that beforehand, we won't go back (no step back)".

Here we refer, for example, to the discussion about the helmet mandatory rule for dressage or the only 3 participants per NF at the Olympic Games.

The whole sport shouldn't be subordinated only to the television broadcast times! Such for example the mandatory short GP, in which all lessons are required, but in a shorter sequence. This is counterproductive for "horse-friendly riding". There will probably be pictures of overstrained horses and riders above all at the Olympic Games! It is already clear to us that broadcasting times achieve sponsorship income but this shouldn't be the only goal.

Another example is in the field of dressage

on page 7, point 4.3.5:

If only the best 18/15 starters are now qualified for the "Individual Test", then this regulation is no longer necessary for the freestyle, especially when there are only 18/15 starters left, so this must be done on page 23 at the top, be defined more precisely (if the Individual Test is the final one.)

But: The Individual Test in the youth classes counts, presumably not only in our country, but also in general to achieve MERs, so you can not only let the best die 18 start there. Some parents and horse owners will decide that I won't even go to that shows with their children and horses only for may be riding 1 test. That is no motivation for the youth!

We are convinced that we would strengthen our sport and also the well-being of the horse more firmly, if the FEI finds back to a more open discussion and exchange with all "stakeholders", although we are also aware that the situation surrounding the ongoing COVID 19 pandemic has us firmly under control.
