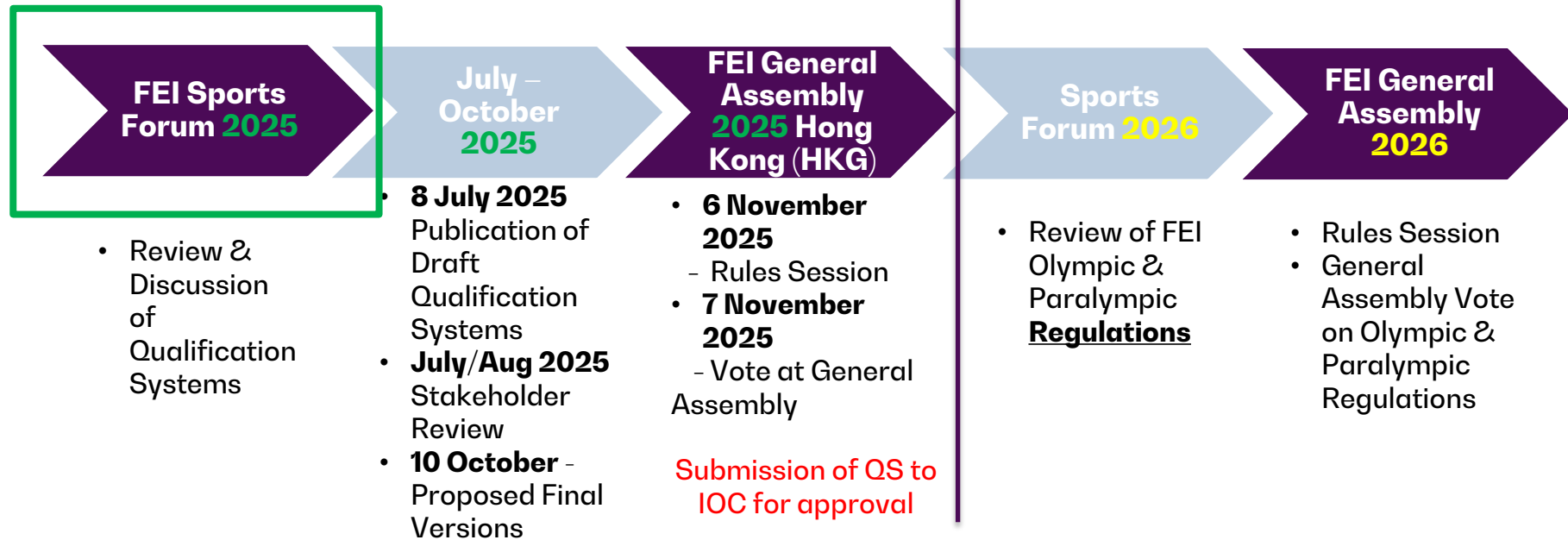

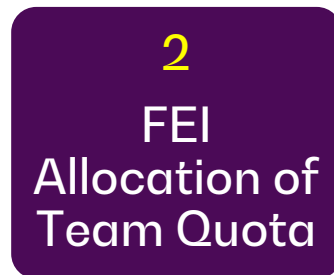

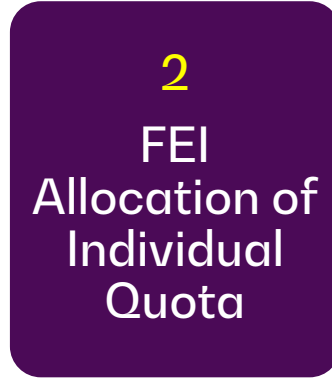

Eventing: Minimum Eligibility Requirements

- MER principle with “Confirmation Result” maintained. **Proposed clarified wording:**

(i) One (1) FEI MER Result at a CCI5-L; or*

(ii) One (1) FEI MER Result in a CCI4-L AND 1 MER Result in a CCI4*-S*

Should the above Result(s) be obtained in 2027, one additional FEI MER Result in a CCI4-S or CCI4*-L or CCI5*-L must be obtained after 1 January 2028 and before 12 June 2028 (the “Confirmation Result”).*

- In case of multiple MERs: must be achieved at a minimum of **2 different venues**.
- One frangible device activation (11 penalty points) or one missed flag (15 penalty points) to allow for an Olympic MER.



Eventing: Olympic Ranking & MER Events

- Lists of 2027 and 2028 selected Olympic Ranking and MER Events for Eventing to be published in December 2026 and December 2027.
- All selected Events to be held at established and experienced venues. Requirement for **one (1) higher level event (i.e. CCI(O)4*-S level, CCI(O)4*-L level), CCI5* level) to be held in the year prior to the Olympic Ranking and MER Event.** Special cases, such as cancellations of past Events due to weather conditions, force majeure, or other exceptional circumstances, will be reviewed by the Eventing Committee.
- Requirement for minimum one FEI Eventing L4 Official to be appointed at the Event (Ground Jury, Technical Delegate or Course Designer).



Eventing: Participation Restriction

- Period in which an Athlete/Horse combination may not obtain an Olympic MER and Olympic Ranking Points.
- When?
 - 24 days after having started the Cross-country test of a CCI4*-L and/or CCI5*-L Event.
 - 10 days after having started the Cross-country test of a CCI4*-S Event.
- Applies to **CCI4*** and **CCI5*** Events only.
- Period is calculated from Cross-Country to Cross-Country.



Eventing: Horse Age Requirement

- Minimum age of Horses for participation in the Los Angeles 2028 Olympic Games set to **nine** years old instead of eight.

Jumping: MER Competitions

- Lists of 2027 and 2028 selected MER Competitions for Jumping to be published in December 2026 and December 2027.
- No addition of Competitions will be accepted after publication of the respective lists of selected Competitions counting for MERs. Replacement in case of cancellation of an Event for force majeure reasons will be reviewed on a case by case basis.

Dressage: Minimum Eligibility Requirements

- To be eligible to participate in the Olympic Games Los Angeles 2028 Dressage Competitions, all Athletes/Horses must achieve, as a combination, the Minimum Eligibility Requirements (**MER**) at selected Events which take place from 1 January 2027 until (and including) the MER Deadline. Athlete/Horse combination must fulfil the minimum eligibility requirements as described below.
- A minimum **67% must be attributed twice** to the Athlete/Horse combination by both a L4 judge and as an average from all judges in the competition, and the score must be achieved in a Grand Prix test at **two different CDI3*/CDI4*/CDI5*/CDI-W/CDIO events**. The two L4 judges must be of a nationality other than of the Athlete. Scores achieved Grand Prix classes (Consolation) judged by three Judges do not count towards the minimum eligibility requirement.

Minimum Eligibility Requirements

- Athletes must be internationally classified with a 'Confirmed' sport class status or a 'Review' sport class status with a review date after 31 December 2028.

Change proposed:

- Increase to two (2) scores of 64% from two different CPEDI3* (or above) between 1 January 2026 and MER Deadline
